Salted Nut Rolls

Ingredients

- 1 package Reese's peanut butter chips
- 1/2 cup butter
- 1 can sweetened condensed milk
- 1 pkg (10 oz.) mini marshmallows
- 1 pkg (11-16 oz.) salted or dry roasted peanuts

Directions

1. In microwave—melt chips and butter together just until chips are melted (don't want it too hot or it will melt the marshmallows and you don't want that). Stir until well blended.

2. Add milk and stir again.

3. Fold / blend in marshmallows.

4. Scatter 1/2 of peanuts on the bottom of a 9 X 13" buttered pan.

5. Spread marshmallow mixture over nuts. (super sticky—clean wet hands help spread a little easier).

6. Scatter rest of peanuts over top.

7. Press down so nuts stick.

Refrigerate for at least an hour. Enjoy!
